

TRAINING & SUPERVISION ACTIVITIES DURING JULY-DEC 2000* -

A. TRAINING

I. National TB Programme (NTP)

a) Regular training course

The 84th training course of eight weeks duration for DTP key personnel on tuberculosis control was conducted at the Institute from 10th July - 1st Sept 2000. The breakup of trainees is given below.

In all, eighty (80) trainees consisting of 15 MOs and 65 paramedicals from different states and union territories of the country participated.
